Kindly refer this office letter No-SHS/NHM/J&K/P&S/13991-14035 dated 21.01.2015 where under advisory from Ministry of Health & Family Welfare, GoI regarding the aforesaid subject were conveyed. As advised by the Ministry all recruitments under NHM should be based on competency based assessment and a representative from Govt. of India/National Health System Resource Centre (NHSRC) should mandatorily be associated as an observer at the time of the conduct of competency assessment and final interview. It was also indicated that no support for HR under NHM would be provided unless recruitments under NHM are done as per the above guidelines.
