3. The selection is further subject to the verification of following certificates in original.
 - (a) Date of birth certificate
 - (b) Permanent residence certificate
 - (c) Hamlet/ward certificate
 - (d) Qualification certificate
 - (e) Any other relevant certificate
4. The objections if any shall be submitted in the office of Child Development Project Officer Reasi within 10 days from the date of publication of this provisional select list in the news paper and no objection shall be entertained thereafter under any circumstances.
