Circular

A meeting of Road Safety Committee was held on 10.04.2017 in the office chamber of the undersigned in which various issues were discussed at threadbare with all the stakeholders. It has been noted that the trends of accidents is increasing every year as per the statistics made available by ARTO Reasi. The directions have been passed to the concerned authorities to take all the preventive measures to minimise the accident in the District including Road Safety Audit, constitution of Quick Rescue Team (QRT), organisation of road safety camps regular checking, laying of Nakas at various places and compounding / challaning the traffic rules violators etc. It is realised that a traffic discipline is to be maintained by the drivers of all the types of vehicles, as major accidents in the District occurred due to the negligence of the drivers.

Now, through the medium of this Circular it is hereby directed that no driver shall ply passengers carrying vehicle in the District without wearing uniform and carrying Identity Card. Further drivers shall not use and carry the mobile phone while driving in their pockets. It should be kept with conductor or locked in 1st Aid Box. The Identity-Cards to the Drivers shall be issued by the ARTO Reasi without Delay.

The Assistant Regional Transport Officer, Reasi, Traffic Police, District Police and all the Executive Magistrates shall ensure the implementation of the circular in letter and spirit.
