Sub:- Extension of date for online – uploading of left out cases of Arms Gun Licences in the NDAL-ALIS portal i.e. 31st, March -2019.

Whereas Ministry of Home Affairs, Govt of India, vide NDAL-ALIS (new portal) Notification dated 17th September, 2018 has extended the date for uploading left out cases of Arms Gun Licences upto 31st, March -2019 to generate "Unique Identification Number" (UIN) in NDAL – ALI System

Whereas all the Arms Licence holders who had either got their licences issued from the Licensing Authority (District Magistrate, Reasi / the then Sub Divisional Magistrates Reasi) or had got the licences issued by other Licensing Authorities however renewed by the Licensing Authority, Reasi are informed through the medium of this notice to get the details of their Gun Licences for uploading the Arms Licences on the NDAL- ALI System of Ministry of Home Affairs, GOI in National Informatics Centre (NIC) Reasi in the office of Deputy Commissioner, Reasi for generating Unique Identification Number (UIN)

Whereas, the Arms Licence which are not uploaded as per the procedure above those Arms Licences were considered invalid with effect from 1st of April, 2019 to date in terms of Rule 54 of Arms Rules, 1962,

Through the medium of this notice, all the Arms licence holders, whose licences are issued/renewed by the Licensing Authority Reasi, (District Magistrate, Reasi /the then Sub Divisional Magistrates, Reasi) or have got the Licences issued by other Licensing Authorities, but are renewed by this office and have not got their Licences uploaded Arms licences in NDAL website are advised to immediately approach to the office of District Informatics Officer, National Informatics Centre (NIC), Deputy Commissioner Office, Reasi for getting their details of the Licences alongwith weapons to be uploaded on the Website of Ministry of Home Affairs (MHA) by or before 31-03-2019 This is the last opportunity for online registration of Arms Gun Licences in NDAL-ALIS portal

As the licences issued/renewed from this office shall not be uploaded on NDAL of MHA website after the expiry of the scheduled date, their weapons shall be deposited in the concerned Police Station as possession of the same will become illegal thereafter
