Sub:-Establishment of Emergency Operation Centre in Deputy Commissioner Office Reasi.

Whereas, heavy rains are expected in the coming days and an urgent need is felt to monitor the situation closely and take all possible measures to prevent the likelihood of loss of life and property due to heavy rains and land slide etc.

Whereas, standing instructions have already been issued in the matter to all the departments to work in coordination in implementing measures through the utilization of existing resources in the District in various departments in order to (i) Prevent the eminent danger/threat of the Disaster (ii) Mitigate or reduce the risk of any disaster (iii) Capacity Building, Preparedness and prompt response to disaster, (iv) Rehabilitation and (v) Evacuation, rescue and relief in case of any disaster.

Now, therefore in order to monitor the overall situation during the current monsoon season an Emergency Operation Centre is hereby established in the Deputy Commissioner Office Reasi in Room No. 115, Phone No. 01991- 244274 which shall remain open round the clock including holiday and Sunday (i.e 24x7). A duty roaster is hereby constituted for the departments as mentioned below for deputing the one responsible official of their department(s) in the Emergency Operation Centre.

The Sub Divisional Magistrates /Tehsildars shall ensure the presence of field functionaries of the Revenue department as well as officers / officials of line departments in their respective jurisdictions.

Keeping in view the fact that human life and property is involved, this assignment assumes supreme importance and thus any dereliction of duty by the officers/officials shall invite disciplinary action without further notice.
