The Election Commission of India has issued following revised schedule for Special Summary Revision of Electoral Rolls with reference to 01.01.2017 as qualifying date vide its letter No:23/ECI/LET/TERR/NORTH-I/J&K/2017 dated 14-09-2016 received through the office of Chief Electoral Officer, J&K Srinagar vide letter No.2614/CEO/Pub/2016/911-943 dated. 15-09-2016

3	Reading of relevant part /section of photo electoral rolls in Gram Sabha/Local Bodies and RWA meetings etc and verification names.	01-10-2016 (Saturday) and 08-10-2016 (Saturday)
4.	Special campaigning dates with Booth Level Agents of political parties for receiving claims and objections.	15-10-2016 (Saturday) and 22-10-2016 (Saturday)
5	Disposal of claims and objections	By 15-11-2016 (Tuesday)
6.	Updating the data base , merging of photographs, updating the Control Tables and preparation and printing of Supplementary list.	By 10-12-2016 (Saturday)
6	Final Publication of Electoral Rolls.	On 10-01-2017 (Tuesday)

The persons who are permanent residents of J&K State and will attain the age of 18 years as on 01.01.2017 or who have already attained the age of 18 years but not registered in the electoral rolls can file their applications on form No.6 for inclusion of their names in the electoral rolls . The persons who are already registered in the electoral rolls but their names are not correctly spelt can also apply on form No.8 for correction.

The application on the prescribed forms i.e. Form No. 6, 7, 8 and 8-A for addition, deletion, correction and transposition respectively as the case may be, can be filed with the BLOs / Tehsildars concerned.

The political parties are requested to give wide publicity to the programme of Special Summary Revision of Electoral Rolls through their party cadres so that no quarter is left for legitimate complaint.
