- 2- (a) The bids shall be deposited in electronic format on website [www.jktenders.gov.in](http://www.jktenders.gov.in) from 28-02-2014 11:00 Am to 6-03-2014 up to 02.00PM). The Technical bids received will be opened in the office of District Dev. Commissioner Reasi online on 8-03-2014 (1:30 PM)  
(b) The complete bidding process will be on line.
- 3- Bid documents can be seen at and downloaded from the website [www.jktenders.gov.in](http://www.jktenders.gov.in) bid documents contain qualifying Criteria for bidder, specifications, conditions and other details.
- 4- The bids must be accompanied by bid security (EMD) in shape of Demand Draft As non-refundable payment of tender documents obtained On line Rs 1000/= for general and Rs 200/= for SSI Units (Rgd). CDRs/FDRs be pledged in favour of Distt. Dev. Commissioner Reasi. The cost of downloaded tender documents in form of DD shall be in separate envelope with cover marking cost of document on or before 06.03.2014 up to 02.00 PM. The non refundable payment of e-re tender documents @ Rs 1000/- for general and Rs 200/- for SSI units registered through demand draft pledged in favour of Distt. Dev. Commissioner Reasi shall be one for all the Nutrition Items from s. No. 01 to 10 and no separate cost of tender document is required to be paid for each nutrition items, the cost of downloaded tender documents in the form of DD and CDRs/FDRs (EMD) in separate envelopes should be reached on or before 06-03-2014 up to 02:00pm along with hard copies of scanned documents.
- 5- The interested bidder can download the NIT/ bidding document from the website [www.jktenders.gov.in](http://www.jktenders.gov.in)
  - (a) To participate in bidding process, bidders have to get "Digital Signature Certificate "(DSC) as per information technology Act. 2000, to participate in online bidding. This certificate will be required for Digitally Signing the bid. The bidders, can get above mentioned digital certificate from any approved vendors. The bidders, who already possess valid (DSC) Digital Signature certificate, need not to procure new Digital Signature Certificate. (DSC)
  - (b) The bidders have to submit their bids online in electronic format with (DSC) Digital Signature. The bids cannot be up loaded without Digital Signature. No proposal will be accepted in physical form.
  - (c) Before submission of online bids, bidder must ensure that scanned copy of all necessary documents have been attached with bid.
  - (d) The department will not be responsible for delay in online submission of bids what so ever reasons may be.
  - (e) All the required information for bid must be filled and submitted online.
  - (f) Bidders should get ready with the scanned copies of cost of documents and EMD as specified in the tender documents.
  - (g) The details of documents, EMD specified in the tender document should be the same, as submitted online (scanned copies) otherwise bid will not be accepted.

(h) Bidders can contact the office of under signed for any guidance for getting (DSC) or any other relevant details in respect of e-tendering process.

(i) All samples should be accompanied with analytical test report of the Govt. approved laboratory /expert opinion of the Govt. Deptt. as applicable, should be deposited in the office of Nodal Officer ICDS, Projects, Reasi by or before 06-03-2014 during office time. No sample will be entertained without the above referred analytical test report/ expert opinion. The rate quoted should be FOR head qtrs of ICDS projects of Distt. Reasi and should be inclusive of all taxes including vat/incidental/handling charges, carriage charges/loading /unloading etc.

The successful tenders shall have to execute agreement with the department and the approved rates shall remain operative up to 30.06.2014.
