Advertisement Notice of 02 of 2014.

Subject: Recruitment of Lab. Attendant (Class IV) direct quota under RMSA Scheme in Education Sector District Cadre Reasi.

In pursuance to the Govt. Order No. 57-Edu of 2013 Dated :- 15-01-2013 and Director School Education No. DSEJ/Gen/5079-99 dated 19-08-2013 , Application on the Annexed format captioned “ Form of application for appointment on Class IV posts in Education Department District Reasi (Annexure-A) are invited from the Permanent Resident of District Reasi for filling up of Lab Attendants (class IV) posts in district Reasi in Education Department .

The recruitment would be effected in light of the Recruitment policy issued vide Govt Order No 257-F of 2011 dated 27-10-2011 read SRO 332 of 2011 dated 28-10-2011. The pay band of the above mentioned posts shall be Rs 4440-7440 with grade pay of Rs 1300. However the selected candidates shall be paid fixed monthly salary for the first five years as per the below mentioned detail in the light of the Govt Order No 257-F dated 27-10-2011.

1. The applicant should not exceed the age limit as mentioned below as on 01-01-2014.
 - (a) Minimum -18 Years
 - (b) Maximum -37 Years
 - (c) SC/ST -40 Years
 - (d) Handicapped -39 Years
 - (e) In case of already in Govt. Service -40 Years
 - (f) Ex-Serviceman -45 Years

2. Total No. of Posts Advertised under RMSA=11 (Eleven)

3. Qualification :-

- (a) Minimum: - Matriculation from recognized Board.
- (b) Maximum: - 10+2 from recognized Board.

However, no weightage shall be given to any candidate for higher qualification.

4. The applicant must be permanent resident of District Reasi.

- (e) A Copy of recent passport size photograph of the applicant duly attested by the Gazatted officer by pasted on the application form.
- (f) Character Certificate (From Gazatted Officer)
- (g) Physically Handicapped certificate indicating percentage of disability, if applicable.
- (h) Ex-Serviceman Certificate issued by the Zila Sainik Board (In case of Ex-Serviceman candidates).
- (i) Self addressed envelope affixed with postal stamp worth Rs 5/-.
- (j) Candidates should submit treasury receipt worth Rs.10/- with the Application Form.

6. How to apply :-

- (a) The form of application duly filled and completed in all respect should be delivered by hand or registered post in the office of concerned Zonal Education Officer, against proper receipt.
- (b) Reservation rules are applicable as per standing direction from the Govt.
- (c) Applications found incomplete in any manner during the scrutiny of applications shall be rejected without assigning any reasons to the applicant.
- (d) The vacancies being advertised are excluding the posts ear-marked for settlement of pending SRO -43 cases.
- (e) Candidate found guilty of impersonation or submitting fabricated document or documents which have been tempered with or making

- statement incorrect or false suppressing material information will render himself/herself liable for criminal prosecution.
- (f) Application if any, already submitted by the candidates will not be considered in the present advertisement and they will have to apply a fresh.
 - (g) No application shall be considered after the expiry of the last date.
 - (h) The application must be deposited within 21 days from the date of publication of the advertisement notice appearing in the newspaper.
