INTERVIEW NOTICE

Sub: - Recruitment of Class-IV Posts (Orderly) and short listing of Candidates
for interview thereof.

With reference to the Notification No. 01 of 2013 Dated: 10-06-2013 issued by this Office whereunder applications were invited for filling up of 03 Nos posts of Class-IV(Orderly) in the District. In response to said notification, a total of 53 applications were received : Open Merit(General): 25 nos., RBA: 13 nos and S.C: 15 nos. After scrutinizing the applications received by this office, all the applications were found valid and no application was rejected on any ground. The following eligible short listed candidates (as per annexure A) in terms of 1:5 ratio (five candidates against one post) in each category are being called for interview to be conducted in the office of Deputy Registrar Cooperative Societies Reasi (Mini Secretariat Block-1 Room No. 309) on **21-02-2014** from 10:30 to onwards.

1. The criteria and eligibility for selection is as under :-

Weightage to basic Qualification (10th) = 60 points (on prorata basis)

Weightage to higher Qualification (12th) = 20 points (on prorata basis)

Viva Voice = 20 points

Total = 100 points

2. The criteria for Short listing of candidates is as under:-

Weightage to basic Qualification (10th) = 90 points (on prorata basis)

Weightage to higher qualification (12th) = 10 points (on prorata basis)

Total = 100 points

3. In case the candidates whose name do not figure in the short list and have got the points more than Cut off points are advised to submit their claims supporting by the documentary proof for consideration to this Office within a week's time (from 10 A.M. to 4 P.M.) from the date of publication of this notice. Thereafter no objection will be entertained.

4. Mere figuring of the name in the short list does not entitle the candidate to appear in the interview as it shall be subject to the scrutiny of all testimonials of the candidates shortlisted.

5. No interview call letter shall be issued separately.

6. The prescribed qualification / reserved category certificate acquired by the candidate after the last date of receipt of application form shall not be entertained.

7. The candidates shall have to produce all original certificate / testimonials at the time of interview. The candidate failing to produce such certificates / testimonials may forfeit their candidature and will not be allowed to appear in the interview.

8. Failure of the candidate to appear in the interview on the above given / notified date shall not be entertained later and shall forfeit his / her right of consideration.

9. Any candidate found guilty of impersonating or submitting fabricated / tempered documents or making false, incorrect or suppressing material information shall render him / her liable for criminal prosecuting under law.

10. All the short listed candidates are advised to submit a certificate from any Gazetted officer, to the selection committee at the time of interview, to the effect that they do not possess qualification higher than 10+2 at the time of submission of application form.

11. No TA / DA shall be paid for participation in the interview.

Note:- the candidates are advised to bring with them Photostat copy of each certificate duly attested by a gazetted officer with his / her Seal and signature and self signed by the candidate himself for depositing with the selection committee at the time of interview in addition to the original documents.
