Consequent upon the release of funds by Social Welfare Department vide Govt. 

**The above release is subject to the following conditions that:-**

1. The funds are utilized for execution of the schemes strictly as per originally approved components and according to the norms and guidelines prescribed by Government of India/State Government.
2. The funds are utilized after the scheme is technically vetted and administratively approved by the competent authority.
3. The funds are utilized exclusively for the purpose for which these are released without creating any liability for future.
4. No diversion of funds in any case is allowed without prior approval of the competent authority.
5. The physical targets commensurate with these funds are achieved in full and there is no shortfall of any kind.
6. That there is no overlapping in funding/covering the area under the scheme from any other scheme of the State/Central Government or any of its organization institutions.
7. A status report about the scheme with physical and financial progress is furnished to this office regularly on monthly basis for close monitoring.
8. The expenditure is incurred as per the guidelines and after observing all the codal formalities required under rules.
9. Drawing and Disbursing Officer shall ensure that the expenditure is authorized to the extent of funds released.
10. The funds so released shall be utilized during the current financial year 2014-15.
11. Utilization certificate shall be furnished to this office well before 31<sup>st</sup> March 2015.
12. Besides the following information/document be furnished to this office against the funds so released.
  - a. Complete detail of work which should include the total cost of the work, expenditure incurred up to March 2015. Physical status of the work prior to and after execution of work alongwith details of beneficiaries/photographs.
  - b. A categorical certificate that the work has been executed as per the approved specification and after fulfillment of all codal formalities.
  - c. A categorical certificate that the work/works have neither been funded nor paid by debit to any other scheme/source.
