<u>ORDER</u>

Subject: Constitution of Vigilance Squads for Secondary School Examinations (10th Class) Annual Session 2015, Regular (Winter Zone).

Whereas, the Secondary School Examinations (10th Class) Annual Session 2015, Regular (Winter Zone) have commenced w.e.f 16-3-2015 in Jammu Province,

Whereas, in order to maintain the law and order and smooth conduct of the examinations in the District, restrictions around the centres have already been imposed under section 144 CrPc vide this office order No: DM/3394-10 dated:14-03-2015,

Whereas, apprehensions have been raised by various people/groups that unfair means may be adopted during the said examinations,

Whereas, Hon'ble Minister for Education has today directed the District Administration to take all possible steps to curb the menace of copying and unfair means in the examination,

Now, therefore, in order to ensure transparency and fairness in the conduct of examinations, vigilance squads comprising of the staff mentioned against each centre enclosed as annexure — "A" are, hereby, constituted to remain present in the Examination Centres during the complete duration of the examination i.e. 10:00 AM to 1:00 PM.

The Vigilance Squad shall ensure that the Examination is conducted in fair and transparent manner and no copying or unfair means are used during the exams. The Vigilance Squads on the detection of the unfair means shall immediately report the matter to the Deputy Commissioner, Reasi along with the evidence collected. Besides, a detailed report about the conduct of examination shall necessarily be submitted by or before 2:00 PM positively, by the Team Leader of the Vigilance Squad.

The Superintendent of Police, Reasi shall provide the necessary support to the Vigilance Squad as and when required for the smooth conduct of examination.



Chief Education Officer, Reasi is directed to inform all the members of Vigilance Squad and ensure that the compliance of order is implemented in letter and spirit, with immediate effect.

The Vigilance Squad shall perform above said duty with supreme sincerity, dedication and commitment. It is pertinent to mention that while this order is being issued, all the Team Leaders of Vigilance Squads have been telephonically communicated about their place and time of duty by the undersigned and therefore any non-compliance in this regard will necessarily invite disciplinary action under *Jammu & Kashmir* (Classification Control and Appeal) Rules, 1956 without further notice.
