Subject: - Provisional select list of Anganwadi Workers and Helpers against vacant slot with respect to ICDS Project Mahore, Arnas and Pouni

As approved and signed by the District Programme Officer (Chairman) selection Committee, the provisional selection list of candidates who appeared in the interview held on 13th and 15th February, 2014 for the post of Anganwadi Workers/Anganwadi Helpers is hereby notified for inviting objections if any, within ten (10) days from the date of publication of this notice in the print media. The provisional selection list of Anganwadi Workers is based on the performance in the interview coupled with the weight-age in respect of academic merit and residential proof submitted by the candidates.

The Select list is provisional and subject to the following conditions that;-

1. The selection of the candidate is liable to be cancelled summarily in case any of the documents/certificate is found fake/forged.
2. The selection is also liable to be cancelled if it comes to the notice that:-
 - a. selected candidate has shifted to the place other than the hamlet/ward for which she has been selected.
 - b. The candidate has furnished wrong address to get herself selected as Anganwadi worker/Helper.
3. The selection is further subjected to the verification of following certificates in original.
 - a. Date of Birth certificate.
 - b. Permanent residence certificate.
 - c. Copy of ration card.
 - d. Minimum qualification certificate.
4. A certificate of hamlet as residence proof duly signed by the concerned Tehsildar/Naib Tehsildar.
5. The objection if any shall be submitted in the office of concerned Child Development Project Officer within 10 days of publication of this provisional select list in newspaper.

NOTE: It must be noted that “No objection” shall be entertained thereafter under any circumstance.

Consequent upon the above, the provisional Select List of the candidates for the post of Anganwadi Workers and Anganwadi Helpers against the vacant posts is given in “Annexure-A” and “Annexure-B” respectively to this Notice.
