**Terms and conditions:-**

1. The contract period of Pyl. Entry Fees/Lorry Adda shall be from 1<sup>st</sup> April - 2014 to 31<sup>st</sup> March - 2015 only.
2. The contractor shall be authorized to collect the tax from such vehicles, which will enter pass through with in limits of Pyl. Pora Kotla (Ransoo) in accordance with the tax schedule of Pyl. Entry Fees/Lorry Adda Tax of department. The Adda Contractor will be authorized to collect the tax from the Driver/ Conductor of vehicles under proper receipt up to his contract period as per below mentioned rates:- The schedule of vehicles and rates chargeable are annexed herewith.
3. The Pyl. Entry Fees/Lorry Adda Tax means which is meaning for parking vehicles with in the jurisdiction of Panchayat Pora-Kotla (Ransoo area).
4. Exemption from Pyl. Entry Fees/Lorry Adda. All Govt./ Military/Police Vehicles which play without charging any fare. The private vehicles which are used for personal purposes are not parked on lorry Adda or other places and personal cars, Jeeps, Ambulance, Maruti Vans which play without freight and fare and also exemption from Pyl. Entry Fees/Lorry Adda tax. The contractor shall be personally responsible to collect the entry fees. If any person, refuses to pay the Pyl. Entry fees/Lorry Adda tax to the contractor, he shall hold vehicle and submit his report to the Secretary Panchayat Pora-Kotla in writing in the same time. The department reserves the right to take any action against the defaulter under law and can also charge the tax 10 times more than prescribed rates.
5. The interesting person / parties can offer sealed bid of Pyl. Entry Fees/Lorry Adda tax contract according to the Auction Notice.
6. The Successfully Bidder shall have to deposit 50% amount in cash / demand draft of the bid, within 24 hrs after close of the bid and rest of the amount shall have to be deposited with in three months i.e. 30<sup>th</sup> of June for which post dated Cheque shall have to be deposited immediately within 24 hrs from the date of personal

7. In case the contractor fails to deposit the 50% (Fifty Percent) of the contractual amount within the above stipulated time, the security of the contractor shall be forfeited and shall be adjusted in the Panchayat Account and no claim / objection shall be entertained or be considered in this behalf and the deptt. shall proceed to collect the contract in a manner it likes to recover the same any body else or itself.
8. In case of any post dated cheques bounces on account of installment, the Pyl. Entry Fees/Lorry Adda will be collected by the deptt. in a manner as will be prescribed at that time and at the risk and cost of the contract. The defaulting contractor shall have no right to recover such amount and legal proceedings shall be initiated against the contractor defaulter to recover the panel amount to default if any under statutory provision.
9. The bidder should be permanent resident of Jammu & Kashmir State and should own processes sufficient moveable / immovable property equal to the half of the offered amount in J&K and a certificate of the revenue officer not below the rank of the Tehsildar concerned / Banker concerned should be enclosed with the offer as a mark of proof.
10. During the contractual period if any new tax is imposed, that shall be recovered by the Deptt. itself. During the contract period, if any loss occurred to the contractor that shall be born by the contractor himself. The department shall not be responsible for the same. If the contractor desired to engage any employee for collection of tax he may do so for which prior approval must be sought from the department.
11. That during the contract period, if any criminal dispute arises between owner of the vehicles, driver or conductor and contractor, the contractor has the right to lodge complaint to the police station under intimation to the Panchayat secretary Pora Kotla/Ransoo.
12. It is compulsory for the contractor to install a board written with entry tax rates at the point of recovery of tax and proper receipt will be given to owner/Driver/Conductor of vehicle as the case may be.
13. If no one presents on the bidding day, the deptt. has the right to fix any other day for the purpose.
14. The contractor must keep with him the terms and conditions of the contract at the collection counter/point of tax.
15. The contractor shall collect the tax as per terms and conditions as laid down and in the arrangement and also liable to avoid by/obey the modification as and when desired by the Govt. /Deptt. from time to time.
16. The earnest money shall be adjusted while making the last installed of the contractual amount and contractor amount shall not be entitled to claim any interest of this amount.
17. The earnest money of the 1<sup>st</sup> highest bidder shall be released only after receiving 50% of the total contractual amount from the 1<sup>st</sup> highest bidder.
18. The record of the contractor is liable to be inspected by the officer/Official of the DPO/BDO, Pouri.



19. The earnest money of ~~Rs. 121 lakh (one lakh twenty one thousand only)~~ in the shape of DD/FDR/CDR from the schedule Bank pledged to Secretary Panchayat Porakotla should be enclosed with the Offer and no offer will be considered if the DD/FDR/CDR of requisite amount is not enclosed.

20. In case of any dispute between the contractors and Department or its Office bearers the same shall be referred to the Director Rural Development Department Jammu/District Panchayat Officer Reasi, whose decision shall be final/conclusive and binding on both the parties.
