Terms & Conditions

1. The arrangements shall be co-terminus with the scheme.
2. The arrangements shall be made at Panchayat level and the candidates belonging to concerned Panchayat shall only be considered.

The applicants shall submit their application Forms to the office of Project Officer, Wage Employment, Reasi (Assistant Commissioner Development) by or before **30th of October 2014 (4:00 PM)**. No application form shall be entertained or accepted after the expiry of the date.

Qualification and Eligibility:-

1. The minimum prescribed qualification required for the post is 10+2. Additional weightage shall be given to the higher qualification.
2. The age of the applicant as on 01.01.2014 should not be less than 18 years and not more than 37 years in case of open merit candidates and 40 years in case of SC/ST/ALC/OSC category candidates.
3. Any act of indiscipline or moral turpitude shall render the incumbent liable for termination.
4. In case large numbers of candidates apply for the post, the department has a right to go for short listing of the candidates on the basis of academic merit.
5. The candidates shall bring original documents at the time of interview, However the candidates are advised to attach photocopy of following documents with application.
 - a. Date of Birth Certificate
 - b. Permanent Residential Certificate.
 - c. Residence Proof of the Panchayat.
 - d. Character Certificate from the Competent Authority.
 - e. Physical Fitness Certificate.
 - f. Additional qualification Certificate (Academic/Technical)
 - g. Experience Certificate if any.
6. The arrangement shall be purely contractual linked inextricably to the availability of funds under management cost under MG-NREGA. The engagement in the first instance shall be made for period of one year & further extension shall be granted on performance basis or till time the funds under the scheme are available, whichever is earlier.
