Whereas, the Government has constituted a committee under the Chairmanship of Deputy Commissioner Reasi for filling up of the vacant post in Katra Development Authority vide Government order no. 175-HUD of 2016 dated. 25-07-2016 issued by the Commissioner/Secretary to Government Housing & Urban Development Department ; and

Whereas, the advertisement for filling up of the vacant post of Junior Assistant was issued by Deputy Commissioner Reasi vide advertisement notice no. 01 of 2017 dated. 22-07-2017 (item no 03); and

Whereas, in response to the above advertisement notice, 64 applications were received for the post of Junior Assistant; and

Whereas, these 64 applications were scrutinized and each candidate was given weight age as per the criteria mentioned in the advertisement notice and all the candidates were called for type test (Computer); and

Whereas, 41 candidates appeared for the type test (Computer) conducted on 02-11-2017 at SMVD University out of which 07 candidates qualified the test and 05 candidates were shortlisted for interview and were called for interview on 27-11-2017 vide Notice No. PS/DC/Rsi/03/2885 dated: 21-11-2017; and


Whereas, all the 05 candidates appeared for interview on 27-11-2017;

Further, the waiting list of 01 candidate is enclosed as "**Annexure C**".




