**Public Notice**

Refer this office public notice issued vide No. DM/Rsi/2680-82 dated: 27-09-2016 wherein all the Arms License holders were advised to get their Arms License detail Uploaded on the National Database of Arms Licenses on the Website of Ministry of Home Affairs.

Now, through the medium of this notice all the Arms Licence holders who have either got their licenses issued from the Licensing Authority District Magistrate Reasi from 01/10/2012 onward or whose licence has been renewed by this office after 30/09/2012 onward are hereby once again, informed that the details of their Gun licenses are to be uploaded through the software National Database of Arms Licenses on the Website of Ministry of Home Affairs and for this purpose a unique identification number is generated for each license.

The Ministry of Home Affairs GOI has once again extended the date for the inclusion of data of leftout Arms licenes & weapons in NDAL portal till 31-3-2017. In case the detail of Arms license is not uploaded on NDAL web portal as per the procedure mentioned above, then the said Arms licenses shall be considered invalid with effect from 1<sup>st</sup> of April 2017 in terms of Rule 54 of Arms Rules, 1962. For the compliance of the statutory requirement, the Arms Licenses issued by this office are being uploaded by National informatics Centre (NIC) Reasi in this office complex of Deputy Commissioner Reasi.

Now, therefore, in view of the above, all the Arms License holders whose licenses are issued by the Licensing Authority District Magistrate, Reasi from 01-10-2012 or Arms Licence holder whose licence has been renewed by this office from 01-10-2012 onward are directed to immediately approach the District Informatics Officer (NIC) Reasi or Judicial Section for getting details of the licenses and weapons uploaded online on the website of Ministry of Home Affairs (MHA) by or before 31-03-2017.

After the expiry of the scheduled date, no license shall be uploaded on MHA website and law shall take its own course against such license holders. In case of failure to get the license uploaded by the due date, the weapon shall have to be deposited with concerned Police Station as possession of the same would become illegal thereafter.
