ADVERTISEMENT

Subject:- Filling up of regular vacancies of teachers in far-flung areas (Socially and Economically Backward areas) on the pattern of Rehbar-e-Taleem Scheme (Govt. order No:- 522-Edu of 2013 Dated:-08-05-2013).

In pursuance to Government Order no:- 635-EDU of 2010 dated:-04-08-2010 and Director School Education Jammu's endorsement No:-DSEJ/RET/5646-56 dated 06-08-2010 & **Govt. order No:- 522-Edu of 2013 Dated:-08-05-2013**, applications are invited from the permanent residents of J&K State, Reasi District for the engagement of RET Teachers in the following schools of different Zones of the District for filling of regular vacancies of teachers in Socially and Educationally Backward areas under J&K reservation rules. Only eligible candidates from the revenue village/village where the school is functioning can apply. In case the school is functioning in TAC/NAC, only the candidate from that very ward can apply. In case of the habitations predominantly inhabited by SC/ST population, only the candidates belonging to these categories and possessing the prescribed qualification shall be considered for engagement as Rehbar-e-Taleem. In case no candidate is available at village level, such posts shall be re-advertised separately. However, where habitations in a revenue village are scattered, the eligibility shall be considered vide Govt. order No:-288-Edu of 2009 and 08-04-2009 wherever applicable. Applications shall be submitted to the concerned Zonal Education Officer's office under proper receipt within 10 days from the publication of this advertisement notice.

The applicant must fulfill the following eligibility conditions:-

1. The age of applicant should not exceed age limit as mentioned below as on 01-01-2013.
 - a) Minimum 18 Years.
 - b) Maximum (General) 37 years.
 - c) SC/ST/RBA 40 years
 - d) Handicapped 39 years
 - e) Ex serviceman 45 Years.
2. The applicant must be permanent resident of J & K State.
3. The applicant must be possessing minimum basic qualification as under:-
 - a) 10+2 pass from recognized Board/University.
 - b) Any qualification acquired after cutoff date of receipt of applications as per this advertisement shall not be considered
4. The applicant must attach the attested Photostat copies of the following certificates/testimonials with the application form:-
 - a. Permanent Resident Certificate.
 - b. Matriculation certificate for Date of Birth (10th class Pass Diploma).
 - c. All Academic Qualification certificates along with marks card.
 - d. Reserve category Certificate issued by the Competent authority under SRO 126 of 1994 & SRO-294 dated:-21-10-2005.
 - e. Self Addressed envelope affixed with postage stamps worth Rs 5/-.
 - f. A copy of recent passport size photograph of the applicant duly attested by the Gazetted officer be paste on the application form.
5. The Applicant shall be selected on the basis of strict merit at village level. The candidate to be appointed should be actually/presently residing in the village where the appointment is to be made.
6. Selected Candidates shall be in receipt of a monthly honorarium @3000 p.m..
7. Number of Vacancies available in each school have been indicated below.
8. The selected candidate shall have to enter into agreement with the department that he/she shall not apply for transfer from the post held by him/her at initial appointment.

9. *The Department shall reserve the right to discontinue the engagement of any RET engaged at any time if his/her performance is not found satisfactory .*
10. *Candidate found guilty of impersonation or submitting fabricated document or documents which have been tempered with or making statement incorrect or false suppressing material in information will render himself/herself liable for criminal prosecution.*
