Subject: Request for final decision on list of "Out of District / Non-Local " AYUSH Candidates for RBSK on lines of other districts.

Sir,

Interviews under RBSK in respect of District Reasi were conducted on 06<sup>th</sup> November 2013 and due to non-availability of doctors in the district interviews of candidates belonging to other districts were also conducted subject to approval of Administrative Secretary, H&ME, as per notification as was done by all other districts.

Thereafter, vide this office letter No. DDCR/2013-14/34/6099-6102 Dated 13.11.2013 approval, under rules, was sought in respect of candidates belonging to other districts. The Administrative Department vide Letter No. HD(GazISMGen-124/2013 instead of according approval forwarded a copy of guidelines citing that "in case local candidates are not available the power to engage non-local candidates shall vest with State Health Society only" and asked to proceed further in the matter under an intimation to the Administrative Department. Technically the department has to accord approval or deny the same but it could not be understood as to why fresh proposal is required to be made before same authority. Moreover there is on cutting on the said letter received in this office.

The Administrative Department, further, vide Letter No. HD(GazISMGen-124/2013 Dated 24.12.2013 reproduced the extracts of the meeting held under the Chairmanship of HCM on 19.10.2010. It is pertinent to mention here that both these letters have been issued under same despatch number on different dates, 10 days apart.

Further, Chief Medical Officer, vide No. CMO/RSI/NRHM/1282-83 Dated 18.12.2013 also approached the Mission Director, NRHM for obtaining approval for hiring the non-local doctors under RBSK. Another reminder was issued by the CMO Vide No. CMO/RSI/NRHM/1339-41 Dated 27.12.2013 to the Mission Director NRHM but the later has not reverted so far despite telephonic discussions by the undersigned.

Hon'ble MLA Reasi Sh Baldev Raj Sharma has written to the undersigned for delay in the matter and Hon'ble Minister for Revenue Relief and Rehabilitation during public meeting at Arnas on 27.12.2013 has also desired an action in the matter.

It is pertinent to mention here that in case of District Ramban a different yardstick was adopted and approval was accorded vide No. PS/Secy/974/H&ME/13 Dated 23.11.2013 and on same day order issued by the NRHM Directorate vide No. SHS/NRHM/J&K/5960-64 Dated 23.11.2013. Interestingly the process of selection of staff was completed by Reasi district before Ramban district and requests were forwarded to concerned authorities on same day however no approval/disapproval has been conveyed to this office.

In this regard, above being the peculiar position, it is requested that a decision may be taken in the matter and conveyed to this office.
