As approved by the Chairman District Health Society (District Development Commissioner Reasi) sealed tenders are invited for Empanelment of Tour/Vehicle Operators in District Reasi for the Mobile Teams under Rashtriya Bal Swasthya Karyakaram in Distt. Reasi.

The interested parties are requested to submit the sealed tenders affixed with Rs. 5.00 revenue stamp (clearly marked on the envelop-Bid for hiring of Vehicle) for the Mobile teams under RBSK in District Reasi. The sealed tenders must reach the office of the Vice Chairman District Health Society Reasi (Chief Medical Officer Reasi) on or before 7th of November 2013 & will be opened in presence of bidders on 09th of November 2013 at 12.00 Noon in the office of the Chairman District Health Society Reasi (District Development Commissioner Reasi). The acceptance and finalization of tenders will be subject to following conditions.

Term and Conditions.-

1. The Vehicle must not be below the model of 2008 and in excellent running condition. (Scorpio/Innova/Tata Sumo/Travera/Indica/Bolero etc.)
2. The vehicle will be hired as and when required by the District Health Society Reasi on the approved rates.
3. The parties may quote the rates for hiring on Daily/Weekly/Monthly and also the rate on per Km basis. The rates should be separately quoted with and without Diesel/Petrol.
4. The hiring is upto 31-3-2014 and may be renewed on the sole discretion of District Health Society Reasi.
5. The successful tenderer shall execute an agreement with the District Health Society Reasi.
6. The District Health Society is empowered to disengage any vehicle any time if the condition of the vehicle is not good and in case of misconduct by driver.
